AMENDMENT NO. 04 TO CONTRACT NO. 182809, RELEASE NO. C-1105(5)

THIS AMENDMENT is by and between the State of Minnesota, acting through its Commissioner of Administration ("State"), and Procellis Technology, Inc., 6820 Shingle Creek Pkwy, Suite 2, Minneapolis, MN 55430 ("Contractor").

WHEREAS, the State has a Contract with the Contractor identified as Contract No. 182809, September 1, 2020 through August 31, 2024 ("Contract"), to provide Computer Cabling and Accessories; and

WHEREAS, Minn. Stat. § 16C.03, subd. 5, affords the Commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

WHEREAS, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contractor in a fully executed amendment to the Contract.

NOW, THEREFORE, it is agreed by the parties to amend the Contract as follows:

1. That Contract No. 182809 is extended through August 31, 2025, at the same prices, terms, and conditions.

This Amendment is effective beginning September 1, 2024, or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.
